PREFACE

This is our pleasure to present the Annual Report-2022. In comparison with last year, the number of out patients has increased by 22%. A total of 189,562 (Male 44%/Female 56%) out-patients received eye care in 2021, while 231,913 (Male 43%/Female 57%) out-patients received eye care in 2022. As compared with last year, there has been a 25% increase in the number of cataract surgeries. In 2021, 10,725 cataract surgeries were performed (45% male/55 female) and in 2022, 13,418 cataract surgeries were performed (45% male/56 female).

The number of ear care services has also increased by 7.64% compared with last year. There were 8669 ear patients in 2021 (male 52% / female 58%) while there were 9331 ear patients in 2022 (male 31% / female 44%).

Among the 13,418 cataract surgeries performed, 7949 were self-financed. The rest were supported by the Tej Kholi & Ruit Foundation, Dak Foundation, I-Care-NABP Norway, Nepal Government, Local Government, CBM, Helping Hands Health Education, Health Insurance, Ek-Ek Paila, and I-Sellurad, Norway.

Besides the general cataract surgery hospital performed for the very first time on 25th January 2022 a major surgery named "Cornea Transplant". Likewise, the hospital also successfully performed another major operation for Retina and Oculoplastic surgery (eyelid and facial plastic surgery).

It is a matter of pride that there is only one eye hospital with specialty service in the project area. Before the setup of specialization service in Rapti, basically only cataract and minor surgery used to be performed. People of Dang had to visit other eye hospitals if they were diagnosed with other eye cases.

Because of the constant advocacy and lobby with the local and provincial government, programme has been succeeded to make hospitals and centres recognized by the government. As a result in 2022 three hospitals have received a total NPR 18,367,379 (NPR Eighteen million three hundred sixty seven thousand three hundred seventy nine). Rapti Eye Hospital has received 10,303,063 (NPR Ten million three hundred three thousand sixty three) for the surgery to poor patients and for Medical Equipment. Chhanda (Kalebabu) Narayani Eye Hospital has received 3,787,175 (NPR Three million seven hundred eighty seven thousand one hundred seventy five) for the support of surgical camps, weekly clinic, purchasing phaco machine and for the construction of staff quarter. Similary Lamahi Eye Hospital received 4,277,141 (NPR Four million two hundred seventy seven thousand one hundred forty one) for the construction work of Koilabas Eye Centre and Lamahi Eye Hospital, for the support of surgical camp and for purchasing medical equipment.

Hospital has been successful to tap government fund and provide comprehensive eye care service to many people with affordable cost, which has contributed to reduce the cataract backlog.

Similarly the programme has maintained the cooperation and collaboration with different organization like Helping Hands Health Education, Dark Foundation, Global Medical Foundation, CBM (Christopher Blindness Mission), Lions Clubs International, Ek-Ek Paila and Tej Kohli Ruit Foundation in 2022 also. As a result programme has received help for performing cataract surgery, purchasing equipment/instrument and kind donation such as glass frame etc.

We would like to extend our sincere thanks to Mr Terje B Iversen, Director International Development Cooperation, NABP, Mr Are Program Director, Ms Sissel Halden and the family of Late Dr Albert Kolstad for their warm support. We are very grateful to NORAD/NABP-Norway for their continuous financial support.

INTRODUCTION

The federal Democratic Republic of Nepal is a landlocked country in the Himalayan Region with the Tibetan Region of the People's Republic of China to the North and India to the South, West and East. Its length is approximately 885 K.M from west to east and has a maximum width of 245 K.M




(Mean width 197 K.M) covering an area of 147181 sq K.M the Country has a mountainous belt to the north covering 35% of the total land area, the flat and highly cultivated Tarai in the South which amounts to 23% of land area and the Central hills in the middle which is 42% of the land area. Administratively the country is divided into 7 Provinces, 77 Districts, 6 metro cities, 11 sub-metro cities, 276 Municipalities, 460 rural Municipalities. Provinces are the first subdivision of the country. Each province is further subdivided into districts, and each district into municipalities and rural municipalities.

BACKGROUND

The World Health Organization in cooperation with Nepal Government (NG) in 1980/81 carried out the most comprehensive blindness survey undertaken in any country until now. In 116 villages and wards all over Nepal, nearly 40000 persons were given an eye examination and many ancillary studies were performed.

The survey showed that in a population of 14 million 0.84% were blind in both eyes. Some of the causes were considered outside the reach of medical prevention or treatment but fortunately, most of the blindness was avoidable. Cataract was the dominant cause with 84%. Next was



trachoma with 3% It was therefore decided to start a blindness prevention project in Seti and

Mahakali Zones, (Sudurpashchim and Lumbini Province) and with support from NORAD, a 100-bed low-cost eye hospital was established in Geta, near to Dhangadhi (than Seti and Mahakali Zones) for various reasons NORAD chose to have Norwegian Church Aid (NCA) take over the project from WHO. This was effected from November 1st 1985, based on an agreement with the Social Welfare Council and Nepal Netra Jyoti Sangh.

The project was extended to Rapti Zone in 1986, where a new hospital was inaugurated in early 1986. Similar projects later started in most of the Zones of Nepal, funded by foreign NGOs under the umbrella of Nepal Netra Jyoti Sangh.

Norwegian Church Aid (NCA) had started to support Eye Health Program establishing the Eye Hospitals at Geta, Dhangadhi -Kailali in 1985 and later in Tulshipur-Dang in 1986.

In 1996 a dialogue was held between NCA & NABP (Norwegian Association of the Blind and Partially Sighted) investigating the possibilities of NABP taking over the NCA's role as a funding partner to the Rapti Eye Hospital, Dang to deliver eye health service in Rapti Zone covering five districts (Dang, Rukum, Rolpa, Salyan and Rukum) NABP showed interest not only in maintaining the previous eye care activities at the Hospital but also in expanding activities in the field of Training/Rehabilitation of blind and partially sighted. NABP took over the role of the NCA as a founding partner to Rapti Eye Hospital, Dang from 1st January 1998 to 2011 and extended its support to Eye Health Program II, Lamahi from 2012.

THE DONOR AGENCY



Norwegian Association of the Blind and Partially Sighted (NABP), a Norwegian International Non-Governmental Organization (INGO), established in

September 1900 as a non-profit-making, secular, non-political self-help organization. This organization works towards full participation and equal rights for blinds and Partially Sighted People. Its primary objectives are to support the strengthening of organizations of the Blind at the national level through making them self-reliant, strong and sustainable, to combat blindness through eye health programs and to promote and support the rehabilitation of blind and partially sighted people. It has been supporting Blind and Partially Sighted people of Nepal in partnership with Nepal Netra Jyoti Sangh (NNJS) and Nepal Association of the Blind (NAB). It has also been programmed in other developing countries.

NEPAL NETRA JYOTI SANGH



Nepal Netra Jyoti Sangh (NNJS) is the leading national eye care providing agency for comprehensive eye care service in the country. It was established in 1978 as a National Society for the prevention and control of blindness. There are 42 district branches of NNJS all over Nepal and 22 Eye Hospitals and 126 primary Eye Care Centers are running under the umbrella of

NNJS. The main role of NNJS is to make a national strategy, supervise, monitor and ensure the quality of services in eye hospitals and centres. It is responsible for overall guidance and leadership for the smooth and efficient running of programs, expansion of program nationwide, coordination with government

and local authorities, instructing the hospital to conduct more activities to reach unreached eye patients, evaluate the target and achievement, train more and more human resource, aware the civil society about preventive and curative remedies of eye care.

WORLD BLINDNESS SITUATION

According to an estimate from the World Health Organization (WHO), about 217 million people are MSVI, 36 million people are blind. In total, 253 million people are visually impaired. 124 million people have uncorrected refractive errors and 65 million have cataract. More than 75% of all blind and MSVI (Moderate and severe vision impairment) is avoidable. There are estimated to be 1.1 billion people with near vision impairment. 89% of vision impaired people live in low- and middle-income countries and 55% of moderate or severely vision impaired people are women. A top leading cause of visual impairment is refractive errors, cataract and age-related macular degeneration (AMD). And a major cause of blindness is cataract, uncorrected refractive error, glaucoma, diabetic retinopathy, corneal opacity and trachoma.1

VISION 2020- RIGHT TO SIGHT

To reduce the global burden of blindness, WHO and a broad coalition of international organizations and private organizations launched a global initiative vision 2020 "Right to Sight" in Geneva 18th February 1999. Similarly, the South Asia Region (SEARO) declared on 30 September for member countries to come forward for the strategies and guidelines for the elimination of Blindness from Region 2020. Perceiving the urgent need to eliminate blindness Government of Nepal formulated "Apex Body for Eye Health" on 6th October 1999 under the Ministry of Nepal and vision 2020 "Right to Sight" program declared at the VI Ophthalmology Congress of SAARC countries held in November 1999 at Kathmandu, The objectives are to eliminate avoidable blindness by developing an integrated approach to disease control, human resource development, as well as infrastructure and technology developmental various levels of the health care system. Nepal is aiming by the end of the 2020 all the districts of Nepal there will be basic eye care facilities and cataract surgical rate (CSR) will be at least 6000.2

BLINDNESS SITUATION OF NEPAL

After the first blindness survey of 1980-81, (prevalence of blindness 0.84%) the second population-based surveys on blindness and visual impairment were conducted in 2006-2010. (Prevalence of blindness 0.35%) In this survey, the rapid assessment of avoidable blindness (RAAB) methodology

was applied. These surveys were conducted in all 14 Zones of Nepal. In total, 39,908 people aged 50 years and older were examined. The eye care infrastructure during the period of 1981 was very minimal in Nepal, with only one eye hospital and 4 eye departments in general hospitals. During this period up to 2010, there were 20 eye hospitals, 19 eye departments, 63 primary eye care centres and the number of ophthalmologists increased from 7 to 147. The number of cataract operations increased from 1,000 in 1981 to more than 200,000 in 2010. Compared with the National Blindness Survey the prevalence of blindness has reduced from 0.84% in 1981 to 0.35% in 2011. The impact of the expansion of eye care service between 1981 and 2011 is the best in the reduction of the prevalence of blindness and visual impairment. In actual numbers, the achievements are far less outspoken because the number of people aged 50 plus more than double between 1981 and 2011 and the life expectancy at birth increased from 48 to 66 year. (Life expectancy has increased to 71 years in 2018)

A RAAB survey of 2006-2010 has revealed that the cataract was the main cause of blindness (65%), from earlier 72% in 1981. This is followed by retinal diseases 9%, corneal diseases 6%, glaucoma 5%, ARMD 4%, refractive error 4%.4

The third RAAB survey 2016-2019 was designed to cover 33845 people in 967 clusters in all seven provinces of Nepal. It was only possible to conduct a RAAB survey in six provinces due to covid-19. As a result of the preliminary data, it seems that there has not been a significant reduction in the prevalence of blindness as compared to the data from the 2010 survey. However, cataract surgery coverage at visual acuity of 3/60 and the visual outcome have significantly improved.

BLINDNESS SITUATION IN PROJECT AREAS

Rapti Eye Hospital has performed various activities and different initiatives were taken to reduce blindness in Dang, Salyan, Rukum, Rolpa, and Pyuthan Districts of Lumbini Province (Than Rapti Zone). In these Districts, the backlog has been reduced from 0.87% in 1981 to 0.13% in 2012 (The RAAB survey 2012). Eye health service has had a big impact in the five districts of Lumbini Province (Than Rapti Zone) and has achieved one of the best results so far in Nepal.

After vision restoration, people have become active; life expectancy has increased (48 in 1981 to 71 in 2017), returned to their regular work which contributed significantly to uplifting their economic condition and living standard. They have started managing their daily life and taking responsibilities for their family. (GDP per capita in Nepal has increased by the US \$ 267.10 to 728.40 period between 1960-2017) (Source: https://tradingeconomics.com/nepal/gdp-growth-annual).

The RAAB survey of 2019 has covered a total of 5,670 people (age group 50+ and above) throughout the province of Lumbini from 162 clusters. The survey has achieved 98.9% response rate. The crude prevelance of blindness from all cause was 2.1%. Similarly, crude prevelance by

all cause of severe vision impairement (SVI) 2.9%, moderate vision impairement 12.6% and early vision impairement were 12.2% respectively.

The crude prevelance of blindness due to bilateral cataract was 1.2%. Similarly, crude prevelance due to bilateral cataract of severe vision impairement (SVI) 2.7%, moderate vision impairement 8.9% and early vision impairement were 12.8% respectively.

The main cause of blindness was untreated cataract (75.7%). Uncorrected refractive error was the leading cause of early visual impairement (EVI) was 66.5%.

EYE HEALTH PROGRAM- RAPTI AND BAHADURGUNJ

Eye Health Program-Rapti & Bahadurgunj is a governing body of three hospitals (Rapti Eye Hospital, Chhanda(kalebabu)-Narayani Eye Hospital and Lamahi Eye Hospital) five primary eye care centres (Salyan Eye Centre, Rukum Eye Centre-West, Rukum Eye Centre-East, Koilabash Eye Centre and Sulichaur Eye Centre, Rolpa) one referral clinic (Krishnanagar referral centre).

VISION

Reduce the prevalence of blindness and visual impairment and improve the quality of life by providing quality eye care service and leading program to an Academic Institution.

MISSION

To provide quality, easily accessible and affordable service under integrated health policy of Nepal Government by strengthening the existing health facilities and increasing the population undercover.

GOAL

Sustainable development of Eye Health Program- Rapti & Bahadurgunj by the year 2024.

OBJECTIVE

To sensitize general people and make them aware of eye health.

To support the National Health Policy of Nepal.

To equip hospitals with modern technology as per the long term strategic plan and gradually develop infrastructure of Hospitals as per the master plan.

To upgrade CKNEH and Lamahi Eye Hopsital from secondary to tertiary level hospital.

CATCHMENT AREAS

Eye Health Program- Rapti & Bahadurgunj has been providing eye health service in 4 districts of Lumbini Province (Dang, Rolpa, Pyuthan and Kapilbastu) and 2 districts of Karnali Province (Western Rukum and Salyan). There are 1.47 million Populations in Dang, Rolpa, Pyuthan, Salyan and Eastern, Western Rukum districts and .57 million populations are in Kapilbastu District.

HOSPITALS/PECC UNDER EYE HEALTH PROGRAM-RAPTI & BAHADURGUNJ

RAPTI EYE HOSPITAL

Rapti eye hospital is located at Raksyachaur-4, Tulsipur, Dang, Lumbini Province. It has 4 Bigha (2.70 hectares) land which is registered in the name of Nepal Netra Jyoti Sangh. According to the Nepal Blindness Survey of 1981, the prevalence of blindness in the Rapti Zone was 0.87% which was reduced to 0.13% in the second survey of 2010 (RAAB Survey). Rapti Eye Hospital was

established in 1986 with support the Norwegian Church Aid (NCA), Norway. Later in 1996, a dialogue was held between NCA & **NABP** (Norwegian Association of the Blind and Partially Sighted) investigating possibilities of NABP taking over the NCA's role as a funding partner Rapti the to Eye Hospital, Dang. NABP



showed interest not only in maintaining the previous eye care activities at the Hospital but also in expanding activities in the field of Training/Rehabilitation of blind and partially sighted. NABP took over the role of NCA as a funding partner to Rapti Eye Hospital, Dang from 1st January 1998 to 2011. Later NABP extended its support to Eye Health Program II, Lamahi from 2012. There are two eye hospitals (Chhanda Kalebabu Narayani Eye Hospital and Lamahi Eye Hospital) five Primary Eye Care Centres (Salyan Eye Centre, Rukum Eye Centre-West, Rukum Eye Centre-East, Koilabash Eye Centre and Sulichuar Eye Centre-Rolpa). Rapti Eye Hospital has been upgraded from a secondary level to a tertiary level hospital which offers comprehensive eye care services such as curative, preventive, pro-motive, and rehabilitative services as well as four sub-specialty services in Retina, Cornea, Oculoplasty and Pediatric.

LAMAHI EYE HOSPITAL

The Lamahi Eye Hospital was established in 2002 as a satellite weekly clinic of Rapti Eye Hospital in Deukhuri, Dang. It was upgraded from a weekly clinic to a Primary Eye Care Centre on 9th September 2009. Lamahi Town Development Committee, a local authority, provided 2.88 acres of land for the upgration of the secondary level eye hospital. This project was constructed with the

support of NABP-Norway and the foundation stone was laid on 23rd November 2010 after which the construction began and was completed in 2012.

Having a large catchment area, it aims to provide eye care services to the people of Rolpa,



Pyuthan, Arghakhachi, as well as part of the Banke district. The Lamahi Eye Hospital is located in the heart of Lumbini Province which is centrally located between Chhanda (Kalebahu)-Narayani Eye Hospital, Bahadurgunj and Rapti Eye Hospital, Tulsipur. It is close to the Indian border, which is only 33 kilometers away from Lamahi. It has one referral center located at Koilabas, which is near the Indian border and is a very convenience to Indian patients.

CHHANDA(KALEBABU)-NARAYANI EYE HOSPITAL

Chhanda Kalebabu Narayani Eye Hospital was previously started as an Eye Care Centre at

Krishnanagar of Kapilbastu district of Lumbini Province on 1st December 2004. The main objective of the center was to provide eye care for those who are curable blind in order to restore their sight. A door-to-door survey had been conducted by the NAB-Rehabilitation program in Kapilbastu, which had revealed that there were approximately thirteen thousand curable blinds in the area. Based on the survey



results as well as finding curable patients in Kapilbastu, NNJS-Rapti Eye Hospital upgraded this

center into a surgical centre. At the beginning, it was started in a rented house in Krishnanagar, and then it was shifted to Bahadurgunj. Gradually, there was an increase in both the number of Nepalese, as well as the Indian patients in the centre. Ms. Narayani Shah, the owner of the land and building, has donated land to upgrade this center into a full-fledged hospital because of the service provided and the increasing number of patients in the hospital. She donated a 1.41-acre piece of land to the center on September 5th, 2012. A hospital named Chhanda (Kalebabu) Narayani Eye Hospital has been officially named as a tribute to the generous donation made by Ms. Narayani Sha. The foundation stone was laid to commemorate the inauguration of the ward building on 15th July 2014. This hospital is situated in Bahadurgunj of Krishnanagar Municipality which is close to Barhni Bazar, UP India. Hence, Indian patients have good access to this Hospital. Around 60 to 70% of patients visit from India. It has one referral centre at Krishnanagar and weekly clinic at Buddhabhumi rural municipality.

SALYAN EYE CENTRE

This center was established on 1st January 2007 at Khalanga of Salyan District with the administrative support of the Nepal Red Cross Society of Salyan by providing free room for eye care services. But due to less access to patients in Kahalanga, the management team of the Hospital

and the Nepal Red Cross team of Salvan jointly agreed to shift this center to Shreenagar of Salyan from June 2012. This centre is referral centre of Rapti Eye Hospital. The patients referred to Rapti for cataract surgery and other major The treatment. management is in



process to develop this centre into surgical centre. There is a coordination committee team for the overall development of the center. The Nepal Government is providing partial financial support to this center. It is running in a rented Krishi Samagri Sansthan-A government building. The local donor has donated free land at the same place (Shree Nagar) and the team is actively participating to get the fund from the Government at the local level.

RUKUM EYE CENTRE- WEST

The center was established in 2011 at Musikot, Rukum. Rukum District has a population of over .2

million and has been served by this center. This is currently running in a rented house of Nepal Red Cross Society, Rukum. Nepal's government is funding this center partially. Rukum Branch of Nepal Netra Jyoti Sangh was established in 2016 and is responsible for managing the center. A local donor has donated land for the construction of this center, and the team members are seeking funding support for its construction.



SULICHAUR EYE CENTRE, ROLPA

This center was established in Sulichaur, Rolpa on 16th February 2016. Mr. Krishna Bahadur Mahara, the then honourable home minister, inaugurated the center. This centre is the referral centre of Rapti Eye Hospital and Lamahi Eye Hospital. At present this is running in a rented house.



KRISHNANAGAR REFERRAL CLINIC

Krishnanagar Referral Clinic was established in 2014 in order to make it easier for patients to access eye care service and also to strengthen the referral system for CKNEH-Bahadurgunj.



KOILABASH WEEKLY CLINIC

The Koilabash weekly clinic was started in 2013 to make the referral system stronger for Lamahi Eye Hospital. Koilabash is located in the Gadhwa Rural Municipality of Dang, Deukhuri, and is

managed by Lamahi Hospital. Eye The Koilabash is a very small town which is situated on the southern edge of the Dudhwa range of the Siwaliks, at Nepal Border with Uttar Pradesh 5 KM from the village Jarwa on the other side. The distance between



Lamahi Eye Hospital to Koilabash is about 32 KM. The Gadhwa Rural Municipality ward No 9 have donated 10 Kattha (1264 Square Meter) land and Constructed the building for Eye Care Centre. Since 2021, this center has been upgraded to a primary eye care center and is now providing regular eye care services to the community.

PRIMARY EYE CARE CENTRE-EAST RUKUM

PECC-East Rukum was established on 11th May 2019. This centre is fully supported by Local Government of Sishne Rural Municipality. As per the National Health Policy 2076, integration of eye health into basic health system, this




centre was established to provide the eye care service to the very needy people of remote places. It was inaugurated by the Chairman of Sishne Rural Municipality. This centre is running under Joint program i.e technical support is provided by NNJS-Eye Health Program and financial and infrastructure support is provided by Sishne Rural Municipality. A co-ordination committee has been formed for the management as well as development of the centre. Eastern Rukum is the new district (1,161.13 Sq KM) under Lumbini Province and has a total population of 53018.

During the period of 1986-2022 (36 years), a total of 3.40 million people (34 lakhs 5 thousand 295) have received eye health care services (OPD services) through the Eye Health Program-Rapti & Bahadurgunj. Among these numbers, 488,211 (four lakh eighty eight thousand two hundred eleven) received free eye care (OPD service) service.




Under the Eye Health Program-Rapti and Bahadurgunj, each of the three eye hospitals and eye centers provided outpatient service to 231,913 patients (44. % men and 56. % females). There were 189,151 outpatient visits at the OPD last year in 2021 (43.6% men and 56.4% females). In comparison to last year, there has been a significant increase of 18.43 % in patient numbers in the OPD. Gradually, the situation that was adversely affected by Covid-19 has been now became normalize.



EAR SERVICE - 2022


This year, Rapti Eye Hospital has provided OPD service to 2,177 (Male 42%/Female 58%), Lamahi Eye Hospital has provided to 4,821 (Male 42%/Female 58%), CKNEH has provided to 1,727 (Male 44%/Female 56%) and Rukum Eye Centre has provided OPD service to 606 (Male 38%/Female 62%).

Compared to last year of 2021 (8,669), this is increased by 7.09%.



CATARACT SURGERIES - 2022


13 418 cataract surgeries were performed in 2022 (45% males and 55% females). In 2021, only 10,720 cataract surgeries were performed. Since COVID-19, the number of patients at hospitals has gradually increased. This year, outreach activities have also increased.




FREE CATARACT SURGERY- 2022

Out of 13,418 cataract surgeries, a total of 7,949 (59%) cataract surgeries were self-paid. Tej Kohli and Ruit Foundation funded 1255 (9%), DAK Foundation funded 1173 (9%), I-Care/NABP funded 922, (7%) and Local Government funded 839 (6%) cataract surgeries. 547(4%) from CBM, 225

(2%) from Helping hands, 166(1%) from CNNJS, 138(1%) from Health Insurance, 100 (1%) from Ek Ek Paila, 100 (1%) from Global Medical Foundation, and 4 from Hospital Pro-Poor Funds.




A positive trend has been observed in the number of phaco surgeries in the last few years. In 2017, there were 956 phaco surgeries, which is up about 423% in 2022.




OTHER MINOR SURGERY-2022


VISION CORRECTION (REFRACTION SERVICE)-2022

We provided refraction services and corrected the vision of 19,530 patients in 2022 (Male 42% / Female 58%). Total 14,330 patients were treated and their vision was corrected in 2017.



BASIC EYE HEALTH TRAINING-2022

A total of 1237 participants have received basic eye health training in 2022. This includes 808 elected members of municipal and rural municipalities, 105 school teachers, 82 mothers, 65 FCHV, 51 health professionals, 40 PCL nurses, 36 journalists, 35 HAs, and 15 traditional healers.



EYE HEALTH EDUCATION/SCREENING CAMP/SURGICAL CAMPS/AWARNESS PROGRAM

A school eye health education program is an integral part of an awareness and advocacy campaign. The main objective of eye health education is to provide information and knowledge about common eye diseases for early intervention. We had targeted to provide School Health Education to 5000 students (last year achievement was 2679). We succeeded in providing eye health education to 7,920 students.

Free eye checkup for school children was conducted y in 28 schools (while the target was 10 schools). 7,920 students were examined (Boys 46% / Girls 54%). Among them, 107 students (boys 38% / girls 62%) were provided with free glasses.

20 Eye Camp and 99 DST camps were conducted this year. 37,107 patients received OPD service.



SUMMARIZE OF KEY RESULTS:

The following are the main results achieved by Eye Health Programme in 2022:

Vision restoration to blind and visually impaired people through cataract operation and other complicated major eye operation:

This year in 2022, the overall eye health programme performed 13,418 (F 7,401 / M 6,017) cataract surgery and 3,150 (F 1,899 / M 1,251) major surgery through its three hospitals, Rapti Eye Hospital, Chhanda (Kalebabu) Narayani Eye Hospital and Lamahi Eye Hospital and through surgical eye camps.

Successful advocacy programme:

Being motivated by past experience programme visited the Municipality and Rural Municipality offices in their working area several times in connection to series of meeting. They even conducted the felicitation and advocacy programme to the newly elected members in local level (Municipality and Rural Municipality of Kapilvastu, Dang, Rukum and Salyan) right after the local level national election concluded in June. A short proposal and work plan were also submitted to the government before 24th June (before the local government's planning and budgeting program) so that eye health program could be included in the government's budget.

Besides that, the hospital also organized a series of discussion Meetings (an advocacy program) which covered the following topics: "The role and responsibilities of elected members and basic eye health education". The eye health programme had conducted such program in 14 municipalities, rural municipalities of Dang, Salyan, Rukum and Kapilbastu districts.

Because of the constant advocacy and lobby with the local and provincial government, programme has been succeeded to make hospitals and centres recognized by the government. As a result in 2022 three hospitals have received a total NPR 18,367,379 (NPR Eighteen million three hundred sixty seven thousand three hundred seventy nine). Rapti Eye Hospital has received 10,303,063 (NPR Ten million three hundred three thousand sixty three) for the surgery to poor patients and for Medical Equipment. Chhanda (Kalebabu) Narayani Eye Hospital has received 3,787,175 (NPR Three million seven hundred eighty seven thousand one hundred seventy five) for the support of surgical camps, weekly clinic, purchasing phaco machine and for the construction of staff quarter. Similary Lamahi Eye Hospital received 4,277,141 (NPR Four million two hundre seventy seven thousand one hundred forty one) for the construction work of Koilabas Eye Centre and Lamahi Eye Hospital, for the support of surgical camp and for purchasing medical equipment.

One of the main challenges of the programme is to be self-sustainable even after the phase out of NABP support, for which it is necessary to make the eye health in the

attention/priority of the government and seek the government budget. Having frequent meetings and advocacy with the government, in some extent programme has been successful to fulfill its target.

Hospital has been successful to tap government fund and provide comprehensive eye care service to many people with affordable cost, which has contributed to reduce the cataract backlog and enhance the economic empowerment of the poor people of project area.

Cross-cutting issue: Anti-corruption

In December 2022 the Eye Health Programme arranged to provide a training on "Public Procurement Management" in Kathmandu to the members of Procurement Management committee of hospitals, Administrators, Accountants and store keepers of each three hospitals. The objective of providing such training is, after completion of training the key staff of the hospitals related to procurement will gain knowledge on overall procurement policy. The system will be stronger. While going with the right system in initiating and completing the procurement of different expensive equipment/instrument and other logistic in the hospital, there will be transparency. That leads to prevent the chances of embezzlement in procurement in hospitals.

Cross-cutting issue: Women's rights and gender equality

In 2022 the Eye Health Programme organized four meetings on Gender Based Violence in its three eye hospitals, Rapti Eye Hospital, Lamahi Eye Hospital, Chhanda (Kalebabu) Narayani Eye Hospital and one in Ghorahi Municipality office. Representative from different organization working on gender based violence, i.e. Women Police Cell, Human Rights, Women Social Activists were present in the meeting. Blindness in both men and women due to eye injury caused by domestic violence, women rights, gender equality and other similar problems were discussed in the meeting. Since every year Eye Health Programme address and focus on this crucial issue, the trauma case caused by domestic violence has been reducing in all three eye hospitals every year. The data in the table below shows the reducing number of trauma case:

Cross-cutting issue: Climate and environment

In the year 2022, monsoon has been very heavy and lasted for a longer period, which caused devastating flood in many areas of Nepal mainly in western region, Dang and Deukhuri belt where our programme is running. It affected many people and the villages of the region. There were road blockade in many places. The consequence of the flood forbade walking patients to reach the hospitals and centres, which caused the decrease of patient flow and eventually reduction in revenue in the hospitals and centres. The programme had to cancel the scheduled outreach activities.

In 2022 Rapti Eye Hospital worked on plantation with collaboration of Lions Club International. Hospital planted trees in the hospital premise. To upgrade the cleanliness and beauty of the hospital, all three hospitals worked on the surrounding of the hospitals. It is believed that in one hand it enhance the purity of the environment and in other hand it boost up the satisfaction level of the patients.

Cross-cutting issue: Human Rights

The programme in 2022 also has strictly followed the sub clause "Right to Health" under the clause "Human Rights" provisioned in the constitution of Nepal. While delivering different eye health service, carrying out other activities medical as well as administrative hospitals have ensured one motto that "no one is deprived from getting those services due to lack of money, race, cast and creed, religion and geographical areas."

Programme has carried out surgical/screening camps with the motive to reach to unreach in very remote and inaccessible places and provided free surgical and other treatment to many poor, destitute and needy people. If the programme had not gone there, the people of that area never would have reached to the hospitals and received services.

Programme has also addressed the other aspect of human rights that is "Right to information" by conducting Press Meet, Social Audit, gender based violence meeting etc. Programme has disseminated ample information on eye health care service.

Challenges and adaptations

Due to the lack of fund and resource, the infrastructure could not be developed as per master plan in all three eye hospitals. The situation is worse in Chhanda (Kalebabu) Narayani Eye Hospital. Since the construction of buildings are not completed, hospital is not able accommodate the patients when there are more patients. Likewise hospital is very keen to apply the patient centre approach but due to financial constraint, it has also remained only in plan. Patients have to be in the queue in open space under scorching sunlight. Hospital has sought for temporary solution for this problem by renovating old shed for the time being. Although Programme has started the four sub speciality service in Rapti Eye Hospital, there are not adequate equipment/instrument. Some latest modern equipment and instrument is very essential to run these services in full fledge. Programme started to approach local government, NABP and other agencies like Lions Clubs International who provided some funds for purchasing the equipment.

In the process to upgrade Rapti Eye Hospital to Tertiary level eye hospital, programme is working hard to set up five specialty service there, which is mandatory for the same. Four services, Occuloplasty, Retina, Cornea and pediatric service is already launched. Programme had decided to sponsor one existing doctor of the hospital for Glaucoma training as a fifth specialty service. The budget was allocated and the contract paper was also prepared but the doctor denied to sign the bond paper at the eleventh hour. She was not agreed with the clause to be associated with the hospital for three years after the training but in the other hand the specific clause was very crucial point for the hospital. After investing certain amount for the training, hospital definitely expects some sort of assurance from the doctor

that s/he be in the hospital and deliver service. Somehow this has create a tough challenge to the hospital. To overcome this challenge programme is looking for another doctor in her place.

The surgical (Specialty service) charge in our hospital is low compared to other similar eye hospitals. Moreover now a days inflation is high in the country, which has impact on the price of medicine and other essential stuffs required for providing surgery. It has been a challenge even to cover the surgical cost. Hospital has decided to have a meeting on this subject, acquire comparative price of other similar hospitals and reform the new surgical charge with a little increment.

In the hilly areas, where until sometimes back there were only our eye centres (Salyan Eye Centre, Rukum Eye Centre, Sulichaur Eye Centre, Rolpa, Rukumkot Eye Centre, Koilabash Eye Centre and Krishnanagar referral centre) running but now other hospitals as well as the government have also started to open the eye centres parallelly, as a result OPD patient is divided. Sometimes it has been a challenge to even cover the running cost of the centres. To address this challenge we must need to upgrade our centre into a surgical centre. The programme has already a plan and trying to execute it. Programme is approaching the local government and other provisional sources for the funds to purchase basic equipment/instrument needed for performing surgery.

In the past, government used to sponsor ophthalmologists and transfer to different eye hospital under NNJS. From this year (2022), they are not going to depute their sponsored ophthalmologist to NNJS. In the coming days, this might lead to a shortage of ophthalmologists in our hospitals.

Coordination and harmonization

NABP Kathmandu office attended the joint meeting with the donor representative of different eye hospitals, where update of eye health related information, government policy toward health system, problems, challenges and new ideas in terms of similar programmes were exchanged.

Some informal meetings with the partners Nepal Netra Jyoti Sangh (NNJS) and Nepal Association of the Blind (NAB) were conducted in regard to different correlated matters.

Cooperation and collaboration has been made with the local government to tap the fund for which several advocacy/lobby/visits/meetings were carried out with different government offices. As a result the programme has been able to receive NPR 18.36 million rupees from the government in 2022.

Similarly the programme has maintained the cooperation and collaboration with different organization like Helping Hands, Dark Foundation, Global Medical Foundation, CBM (Christopher Blindness Mission), Lions Clubs International and Tej Kohli Ruit Foundation in 2022 also. As a result programme has received help for performing cataract surgery, purchasing equipment/instrument and kind donation such as glass frame etc.

Added Value

Added value in terms of thematic and professional skills and competence:

In 2022 the programme has been able to transform Rapti Eye Hospital to a complete full-fledged Eye Hospital with four sub speciality services i.e. Retina, Cornea, Occuloplasty and Paediatric. Rapti Eye Hospital has been only one eye hospital providing a complete eye care services in the region. This has helped the eye patients in terms of finance and convenience. The Programme has launched "Internal Segment Fellowship" from 2022. This training is provided by the senior doctors as instructor to the junior ophthalmologist and other ophthalmologists from outside the hospital. This helps to enhance the skill of internal existing Ophthalmologists in one hand and in other hand it contributes towards income generation from the outsider candidates.

Added value in terms of organizational and financial competence, network, and experiences:

The programme conducted the felicitation and advocacy programme to the newly elected members in local level (Municipality and Rural Municipality of Kapilvastu, Dang, Rukum and Salyan) right after the local level national election concluded in June. Likewise the hospital also organized a series of discussion Meetings (an advocacy program) in 14 municipalities, rural municipalities of Dang, Salyan, Rukum and Kapilbastu districts. Because of the constant advocacy and lobby with the local and provincial government, programme has been succeeded to make hospitals and centres recognized by the government. As a result in 2022 hospitals have received a total NPR 18,367,379 (NPR Eighteen million three hundred sixty seven thousand three hundred seventy nine) for fulfilling different need of the hospitals. Hospital has been successful to tap government fund and provide comprehensive eye care service to many people with affordable cost, which has contributed to reduce the cataract backlog and enhance the economic empowerment mainly in the project area.

The programme has maintained a very good network with the other organization like Lions Clubs International, Helping Hands, Tej Kohli and Ruit Foundation etc. These organization have helped the programme in many ways, whether in purchasing equipment/instrument or for cataract surgery.

Added value for civil society:

In 2022 the Eye Health Programme organized four meetings on Gender Based Violence in its three eye hospitals, Rapti Eye Hospital, Lamahi Eye Hospital, Chhanda (Kalebabu) Narayani Eye Hospital and one in Ghorahi Municipality office.

Programme has played vital role to reduce the cataract backlog in the project area. Government has also realised this fact hence as a result Dr. Sulaxmi Katuwal, Chief Medical Director has been awarded by a prestigious award "Jana Sewa Shree Medal" by the President of Nepal for the good job carried away in the sector of Eye Health Service.

When there was flood in the Dang and Deukhuri area and it had affected the local people a lot, Programme had helped the local people through government by providing some rice and other stuff in the flood stricken area.








the cornea transplant surgery. After the surgery the doctor suggests her to visit
